Terms of Sale

Cherry Republic establishes credit with a credit card. All major cards are accepted. After credit is established by initial three orders, terms of Net 30 days may be requested. Orders can also be prepaid with a check or money order. A waiting period of two weeks is required from receipt of check to shipment of order. A \$25.00 charge will be applied for any returned checks. Payment is expected within previously arranged terms. Past due accounts may be subject to the following, with or without prior notification: charges to credit card on file, change of payment terms, holding of pending orders until payment is received, or placement with a collections agency to recover funds. Late balances will be subject to 1.5% interest charge. Accounts are expected to purchase a minimum of \$1,000 in each year of business with Cherry Republic and order at least once every six months to be considered eligible for reorder the following year.

Terms & Conditions

You must have a storefront location and valid Tax ID Number. These businesses include, but are not limited to: specialty food stores, gift stores, seasonal farm markets, gift basket businesses, restaurants and event management companies with approval. Products that are purchased from Cherry Republic at wholesale prices are for resale in your specified location only. Reseller will not sell or otherwise transfer Cherry Republic products to any affiliates. Cherry Republic prohibits resale of our products in the following ways: internet short sale (ebay, amazon, etc.); mail order; gift/trade/holiday shows of any kind; or distribution to businesses other than your own.

Pricing and Availability

Prices are subject to change without prior notification. Please call for availability of large quantity orders. Products must be resold at or above Cherry Republic's suggested retail price.

_____ Reseller agrees that selling in locations other than authorized locations will cause damage to Cherry Republic in an amount that cannot be determined at this time but agrees to pay for said damages (including attorney's fees) that result from Reseller's failure to comply with the requirements herein.

- All returned products must be in original packaging and in resalable condition.
